In August, Brian Hotz, Forest Society V-P for Land Conservation, told Beth that the Forest Society has been working on trying to find a way to buy the San-Ken parcel on Swamp Road. A land swap is not possible because all the land the Society owns in Sharon is subject to restrictions that require it always be used for conservation. Sometimes the Society is given land not subject to such restrictions, but Brian said they do not have any unrestricted land anywhere in this area.
